

STATISTICAL REPORT FOR THE FISCAL YEAR OCTOBER 1, 2024 - SEPTEMBER 30, 2025

During the fiscal year, October 1, 2024, to September 30, 2025, the Court of Federal Claims disposed of 997 complaints and 1,331 vaccine petitions. Except for a number of these cases in which no given amounts were claimed, the total amount claimed was \$231,610,389,000.00. Of the cases disposed, the court rendered judgments for claimants in the sum of \$579,243,840.38 (annuity amounts are included in this figure if available) of which \$56,879,239.94 carried interest. A number of these judgments were based on settlements between parties. The Court of Federal Claims rendered money judgments for the United States on counterclaims, offsets and/or sanctions in the sum of \$0.00. Under its non-monetary jurisdiction (bid protest jurisdiction), there were 234 cases filed and the court disposed of 247 cases.

Case filings increased in fiscal year 2025 for general jurisdiction cases and vaccine injury compensation cases. General¹ jurisdiction cases increased by 7.7% while vaccine petitions increased by 9.5%. There were 943 general jurisdiction cases, approximately 9.9%, with multiple plaintiffs and 10.7% involved intervening parties.

Total case terminations decreased 2.9% from 2,377 in fiscal year 2024 to 2,308 in fiscal year 2025. Pending cases at the close of the fiscal year decreased 0.59% from 5,435 on September 30, 2024, to 5,403 on September 30, 2025.
